SELLER: Seller guarantees that the puppy has had proper care to date and has been checked by a veterinarian. Puppy has received its first shots and wormed. Records will be provided when puppy is picked-up.

•Seller is not responsible if puppy contracts a communicable disease after leaving breeder's possession. This includes: worms, fleas, mites, cocci, giardia, or any other parasite common in dogs and puppies
*Relocation, travel and separation from their litter mates can stress a puppy causing the puppy not to eat properly for a few days. This should clear up in a few days. If it does not, have a veterinarian examine it.

•Temperament of the puppy, color, size, or look of any puppy is not guaranteed.

Seller will offer a warranty until the age of 12 months from the birth date on any puppy with clinical signs of any genetic health conditions (injuries are not applicable). If a condition, does arise, the steps below must be followed:

◆ Please notify Lil' Sunbeams by mail or personally

◆Supply Seller with a letter from a veterinarian stating that in his/her opinion the condition is congenital along with copies of all vet checks, proof of vaccinations, etc.

WARRANTY: *In the unfortunate case that one of the above conditions occurs, the Seller will at their sole discretion do one of the following:*

- *Upon receipt of notifications and all required documentation, Seller will at their discretion take the puppy back and replace it with a puppy of equal value and of the same sex from a litter of Sellers choice at the Sellers convenience. Puppy must be returned to the Seller (along with papers) at Buyer's expense. Seller will not be held liable for any expenses incurred by Buyer, including but not limited to vet bills and transportation costs.*
- *Seller will refund the price that was paid for this puppy.*
- *All veterinarian fees and expenses shall be the responsibility of the Buyer(s). Under no circumstance shall Lil' Sunbeams, its owners, operators, or employees be held responsible for any expenses for any puppy not in the possession of Ruth King.*

BUYER: *Buyer guarantees that:*

- *the dog will reside with Buyer as a companion to buyer and buyers family*
- *Buyer will not keep the dog chained, tethered, or permanently housed in a kennel*
- *Buyer will provide the dog with nutritious food and necessary veterinary care, including deworming , heartworm prevention, and regular vaccinations*
- *Buyer will not sell, give, or release the dog to a pet shop, retail store, dog dealer, animal testing facility or an agent for any such business or facility.*
- *If for any reason the dog must be sold, given, or released to a new home, Buyer will first do one of the following:*

In any situation, Seller will have first option to buy the dog back for purchase price.

Seller also highly recommends that this puppy to be registered with AKC (papers provided at purchase), within 3 months of purchase. Also consider enrolling your puppy in beginner obedience classes. A well trained puppy/dog is desirable to be around.

This entire agreement between the two parties is not transferable.

In case of dispute, buyer gives up all rights to a jury or civil trial and agrees to binding arbitration, at Buyer's expense, and any legal action for whatever reason would take place in the state and county of the residence of the Seller.
